Sealed of Electronic bids must be submitted to the office of **Madi Rural Municipality, Ghartigaun, Rolpa** through web portal **www.bolpatra.gov.np/egp** on or before **12:00 on 2077/08/28 (13th December, 2020)** and for sealed quotation **2020-11-27 (2077/08/12)**. Bids received after this deadline will be rejected.

For **contracts No. MRM/Work/NCB/03/04/05-077/78** technical bid will be opened electronically and for all other contracts bids will be opened electronically at once electronically immediately in the presence of Bidders' representatives, who choose to attend at **14:00 on 2077/08/28 (13th December, 2020)** and for sealed quotation at **14:00 2020-11-27 (2077/08/12)** specified above at **Madi Rural Municipality, Ghartigaun, Rolpa**. Bids must be valid for a period of **90 days and 45 days** for all contracts after bid opening **and** must be accompanied by a bid security valid for at least 30 days beyond the bid validity period respectively.
7. If the last date of Pre-Bid meeting/purchasing/submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bidders may submit modification or withdrawal prior to the deadline prescribed for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will no be able to submit another bid response for the same bid.
9. After the completion of evaluation of Technical Bids, which are substantially responsive evaluated bidders, will be invited to attend the opening of Price Bids. The date, time and location of opening of Price Bid shall be notified in writing and/or published in national daily.
10. Other information not mentioned above is as per Public Procurement Act 2063 and Public Procurement Regulation 2064 with latest amendment.
11. The employer reserves the right to amend and correct at any time, in case of any discrepancies or error in bidding document, tender notice or any other document.
